After taking into consideration:

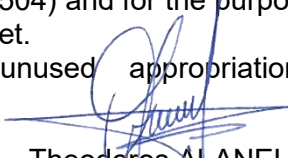
1. The provisions of the:

2. The NU.02/17 June 2026 approved request for commitment of the FN Support Branch Head, which has been competently approved, regarding the necessity and the feasibility of the respective need;
3. The fact that the amount of the credits committed with this decision is within the appropriations foreseen according to the IAMD COE Medium – Term Financial Plan (MTFP) 2027-2031;

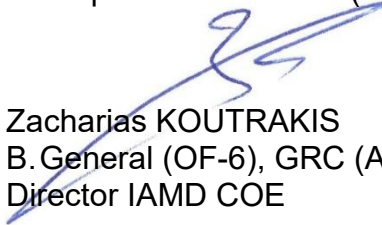
